Use Overview

Suma® Stop Slip^{TMMC} D3.3 Traction Treatment is designed to be applied full strength for traction texture treatment, which micro-texturizes the tile floor, helping make the floor safer. Use diluted for effective daily floor cleaning.

Avoid contamination of food during use or storage. Do not use on food contact surfaces.

Traction Treatment (once per month or to spot treat slippery areas)

- Use floor cones to mark off area to be treated. Wipe up spills and sweep up debris.
- Apply a heavy coat of this product full strength using a clean mop and bucket without a wringer. Evenly spread this product across the floor.
- On guarry tile, allow to stand for 20 minutes and agitate with a deck brush or other agitation tool.
- On ceramic and porcelain tile, allow to stand for an additional 20 minutes so that the total contact time is 40 minutes. If the surface starts to dry out, reapply this product to keep floor wet. On glazed tile, Suma® Stop Slip^{™MC} Traction Treatment can dull/discolor tile as it works to improve the floors' slip resistance (when used full strength, always test Suma® Stop Slip^{™/MC} Traction Treatment first in an inconspicuous area).
- Mop up solution or squeegee to floor drain. Rinse or damp mop floor with water.
- > Dry floor surface using a wrung out mop or squeegee.

Daily Cleaning

- Use floor cones to mark off area to be cleaned. Wipe up spills and sweep up debris.
- Dispense or mix proper strength solution of product and warm water in a mop bucket.
- Using a clean mop, apply the cleaning solution generously to the floor, overlapping mop strokes. For best results, scrub the floor with a deck brush, especially if the floor has grout and allow the cleaning solution to stand for 10 minutes before rinsing or using squeegee.
- Repeat if necessary on heavily soiled areas. Pick up soil and excess solution with a tightly wrung out mop, wringing it out frequently, or squeegee to floor drain. Rinse or damp mop floor clean.
- Dry mop or squeegee floor dry or allow floor to air dry before reuse. Once dry, remove "Wet Floor" signs.

Note: Floor will be slippery when wet or contaminated with foreign materials. Promptly clean up spills and foreign materials.
